The report carries with it and implies no guarantee against faulty design, latent or other defects or the suitability of the boat for any particular purpose, nor any guarantee of compliance with any particular national or international rule, requirement, regulation, law, standard or code unless specifically requested as a specific request on this form and confirmed in the text of the report. It is agreed that liability for the report is solely to the instructing client and to no other third party unless otherwise specified and agreed. It is further agreed that no further liability will arise for any consequential or economic loss, loss of profits or business interruptions or loss of use.

I/We¹ acknowledge that this survey contract shall be governed by and construed in accordance with English law and that any dispute arising there from shall be submitted to the exclusive jurisdiction of the Courts of London, England.
